The President's Message

The latest Board meeting of the Executive Estates of Boynton Beach Homeowners' Association, Inc. (Citrus Glen HOA) was held on March 27,2007. Our Property Manager, Scott Straleau, reported that we are obtaining bids to trim the community palms. He also informed those members present that the broken community sidewalks have been repaired. Scott also mentioned that 188-Temple Avenue is going into foreclosure and stated that the current mortgage on this property is significantly higher than the property value.

The President suggested that the community make some changes to a driveway in our community. The original installation caused the adjacent grass to be damaged with traffic and to be wash out in heavy rain, leaving mud where grass had been. The Board requested Gulfstream to obtain bids on this job so that it may be presented at the next Board meeting for approval or disapproval.

Bob reported some problems with the front entranceway resulting from the children who await their morning school buses in the area. There was one situation in which a child tried to jump over the lift-arm gate and actually broke the arm of the gate. Bob is going to show the video of this event to city officials and seek their help to resolve the problem. That help could take the form of placing a crossing guard at that location or changing the pick-up point. Bob reminds all residents to be especially careful driving their vehicles through that school bus stop. We all know from experience that children playing tend to forget that there are many dangers lurking about and occasionally will dart into the road without looking first. None of us wants to go through the pain and suffering related to causing a child's injury, or anyone's for that matter.

We are pleased to report that we have many new residents. The Board extends a warm welcome to them and an offer of assistance to help make them comfortable in any reasonable way. New residents should keep in mind that this is a well established, gated community which is partly governed by a set of documents containing Covenants, Restrictions and Rules and Regulations. Each of us should become familiar with those documents and abide by them. We all agreed to do so at the time we purchased our house. We also received welcome documents at the new homeowners interview with the basic rules. Please become familiar with all the documents to insure compliance and avoid difficulties.



Energy Saving Tips

Ceiling Fans

Fans circulate the air in your home and can also help reduce your A/C costs. That's because they allow you to set your thermostat higher and still feel cool. Tips for efficiency include:

- * Turn off your ceiling fan when you leave the room. A fan that runs constantly can cost up to \$9 a month, depending on size and age.
- * When buying a fan, choose the right size for the room. For example:
- * 10×10 -foot room or smaller = 36-inch fan
- * 15×20 -foot room = 52-inch fan
- * Rooms larger than 15×20 feet = two 52-inch fans

Refrigerator/Freezer

After air conditioning and water heating, your refrigerator is the third-largest user of energy in your home.

Here are some quick tips to help you use your refrigerator and freezer more efficiently:

- * Avoid using multiple refrigerators. If you have an extra refrigerator that is not kept full or is hardly used, turn it off or get rid of it. It can save you up to \$100 a year.
- * Keep your freezer full. This will help keep warm air out when the door is opened.
- * Cover your food before storing it.
- * Get everything you need out at one time to prevent cool air from escaping.

These tips can help you trim energy costs, but the best time to save is when buying a new, energy-efficient refrigerator. Follow these simple steps to make sure you're getting the model that's right for your home:

- 1. Select the right size.
- * Larger refrigerators may cost more to run.
- 2. Compare features and energy use.
- * Side-by-side models use more energy than topand-bottom models.

- * Automatic ice and water dispensers increase energy use.
- 3. Compare prices and check the Energy Guide label for operating costs of the models you're considering.

Washer and Dryer

Around 90 percent of the energy used to wash clothes is from heating the water. Therefore, to save energy and money, FPL recommends that you

- * adjust the water level on your washing machine to match load size, especially when using hot water, and
- * use cold water whenever possible and always use a cold rinse.

Efficiency tips for your dryer include:


- * Clean the lint filter before every load.
- * Don't overload the dryer.
- * Use the auto sensor function on your dryer, if you have one, to avoid over-drying your clothes. If not, try setting the timer 15 minutes less than usual and see if they are dry.

When buying a new washer and dryer, here are some helpful hints:

- * Buy a dryer that has an auto-dry sensor. This detects when your clothes are dry and automatically turns your dryer off to avoid over-drying clothes and wasting energy.
- * Look for machines that offer several water temperature selections for the wash and rinse cycles. The most efficient new washers are front loading, which saves both energy and water. They also spin the clothes faster, which reduces drying time.

Compare prices and check the Energy Guide label for operating costs of the models you're considering. Dryers are not required to carry this label.

Trash Information



Curbside recycling is available to all residences in the City and is picked up on a weekly basis. Residents are asked to place the following items in the colored bins indicated:

YELLOW

Newspapers Corrugated Cardboard Boxes Magazines Catalogs Telephone Books

Corrugated cardboard boxes need to be flattened and cut to 2' x 2' sections. Place the cardboard in, or next to,the yellow recycling container. We recognize that it is sometimes difficult to flatten and reduce the size of cardboard. However, our recycling trucks can only accept material that is around 2' x 2' in size. Also, the recycling trucks do not compact their contents. Thus, if cardboard is not flattened we would be carrying many empty boxes full of air causing multiple trips to the disposal site. This would add cost to your monthly services.
