As a condition precedent to granting approval of any request for a change, alteration or addition to the existing landscaping, that the applicant, the heirs and assigns thereto, hereby assume sole responsibility and accept the changes to the landscaping of the area involved. The applicant hereby waives any rights to request the association to return the area to its original condition. It is understood and agreed that the Association and the Management Company are not required to take any action to the repair, or replace any such approved change, alteration or addition, or any damage resulting there from for any reason to the existing landscaping or any other property. **THE UNIT OWNER ASSUMES ALL RESPONSIBILITY AND COST FOR ANY ADDITION OR CHANGE, AND REPAIR FOR ANY DAMAGE TO THE AREA OR TO ANY ADJACENT PROPERTY.**
